

Under the above circumstance the Karnataka State Fire & Emergency Services Department is issuing the **"Fire Safety Compliance Report"** M/s. **Deccan Foundation** situated at **M/s. Deccan International School, Sy. No.36/3, Khatha No.144, N-Vaddahalli Village, Padmagatta Post, Mulbagal Taluk, Kolar District-563 132** subject to proper maintenance of firefighting installations in the good working conditions and arrange for 40% of staffs/employees training within 03 months from the date of issue of this report.

In case the Fire prevention and Fire Fighting measures installed as per the recommendation of the department are not maintained in good working condition, if the evacuation measures are not properly followed and if any additional construction work is taken up in the building/premises, the Fire Safety Compliance Report deemed to be cancelled and necessary legal action will be initiated against the developer/management/tenant and also separate NOC has to be obtained from the department for the storage of chemicals, solvents, petroleum products(Diesel/Petrol), LPG, etc. in the premises/building.

"This Report is Valid up to 09-06-2026 and should be renewed without fail before the validity period".
